3. INSECTICIDES, PESTICIDES

It is also necessary to avoid global diseases like Aid HV viruses as it is seemed more prominent in malnutrition and persons suffering tuberculosis. Sex education with point of age must be made mandatory under the law of Global Health.

10. BIRTH CONTROL

The artificial methods of birth control must be discouraged under the law as it gives rise to defective vein blood circulation, obesity and so many physical and psychological problems in mating couples.

To protect the human race characteristics and identification, the process and techniques of cloning
