- Mar.* 13. THE HON'BLE SIR SHAH SULAIMAN, a Judge of the Federal Court, died after a brief illness.
- Apr.* 15. THE HON'BLE SIR JOHN BEAUMONT, Chief Justice of Bombay was appointed an Acting Judge of the Federal Court and held the office up to 31st May.
- Oct.* 7. THE HON'BLE SIR MUHAMMAD ZAFRULLAH KHAN, K.C.S.I., Barrister-at-Law, sometime a Member of the Governor-General's Executive Council, was sworn in as a Judge of the Federal Court in succession to THE HON'BLE SIR SHAH SULAIMAN, deceased.
