MEMORANDA.

1937.

Oct. 1. SIR MAURICE LINFORD GWYER, K.C.B., K.C.S.I., one of His Majesty's Counsel, The Hon'ble Sir Shah Muhammad Sulaiman, Chief Justice of Allahabad, and Mukund Rambao Jayakar, Esq., Barrister-at-Law, an Advocate of the High Court of Bombay, were sworn in at Viceregal Lodge, Simla, as Chief Justice and Judges respectively of the Federal Court.

Jan. 6. The Hon'ble Mr. Justice M. R. Jayakar was appointed to be a Member of the Judicial Committee of the Privy Council, under the Appellate Jurisdiction Act, 1929, in place of The Right Hon'ble Sir Shadi Lal, resigned.

Feb. 27. The Hon'ble Mr. Justice Srinivasa Varadachariar, a Judge of the High Court of Madras, was sworn in as a Judge of the Federal Court in succession to The Hon'ble Mr. Justice M. R. Jayakar, resigned. He was afterwards knighted.

Apr. 1. Sir Brojendra Lal Mitter, K.C.S.I., Barrister-at-Law, an Advocate of the High Court of Calcutta, was appointed to be Advocate-General of India.
