MULLA AND PRATT ON THE INDIAN STAMP ACT (7th ed. 1990). By Salil K. Roy Chowdhury and H.K. Saharay. N. M. Tripathi Pvt. Ltd., Bombay. Pp. xxxv + 479. Price Rs. 130.

THE SUBJECT of the "rates of stamp duty in respect of documents other than those specified in the provisions of List I with regard to rates of stamp duty" is covered in Entry 63 of the List II-State List. Therefore, though the Indian Stamp Act was enacted in 1899 for India as a whole, the current rates of stamp duty are to be found only in the various amendments made by the states to the articles in the schedule to the Stamp Act. Hence a commentary on the Indian Stamp Act is useful only when it gives the reader all the state amendments so made.

The chief merit of the present book is that it purports to give all the different rates of stamp duty in respect of the various documents liable to such duty under the schedule to the Indian Stamp Act as fixed by the various states.

As for the commentary on the sections and articles of the Stamp Act, it is substantially the commentary written by Mulla and Pratt. The late D.F. Mulla was by far the commentator par excellence in India. His commentaries have been marked by clarity and precision. A perusal of the citation of the case law in this book would show that the cases digested are mostly those which have been so digested by Mulla and Pratt. Though the latest statutory amendments made by the states to the Stamp Act seem to have been covered, reference to the recent judicial decisions is conspicuous by its absence. This is not surprising. The editors of Mulla's Commentaries, whether of the Code of Civil Procedure, volumes 1 and 2 or of the Stamp Act have not been able to bring the case law in these commentaries upto date. With this reservation, the book is, as it has always been, a good standard commentary on the Stamp Act by Mulla and Pratt and is recommended to the reading public as such. An interested reader will have to supplement the commentary with his own research in respect of the latest judicial decisions.
