MEMORANDA.

ON the 2nd day of April 1870, the Hon. Sir ADAM BITTLESTON resigned, and JAMES KERNAN, Esq., Q. C., was appointed a Judge of the High Court, and entered upon his duties on the 2nd June 1870.

On the 30th day of April 1870, the Hon. C. COLLETT left Madras, on fifteen months' leave of absence, and JOHN ROBERT KINDERSLEY, Esq., of the Madras Civil Service, (Acting Judicial Commissioner of Mysore), was appointed until further orders and continued to discharge the duties of Judge until the 15th August 1870.

On the 2nd day of December 1870, Sir COLLEY H. SCOTLAND, Chief Justice, left Madras for a short period, and the Hon. W. HOLLOWAY was appointed to act as Chief Justice; whereupon the Hon. J. R. KINDERSLEY was again appointed to a seat in the High Court until further orders.
